WHEREAS: THE REVOTE WAS REQUESTED ON ACCOUNT OF SIGNIFICANT PROBLEMS WITH THE ORIGINAL VOTE WHICH IN QUANTITY AND QUALITY CHANGED THE OUTCOME OF THE VOTE;

AND WHEREAS; THE MEMBERSHIP VOTED OVERWHELMING FOR A REVOTE;

AND WHEREAS; BROTHER CASUTI DECIDED NOT TO HOLD THE REVOTE;

AND WHEREAS; THE INTERNATIONAL EXECUTIVE BOARD UPHELD BROTHER CASUTI'S DECISION;

AND WHEREAS; THE DECISION NOT TO HOLD THE REVOTE WAS APPEALED BY MYSELF TO THE 55TH ATU CONVENTION HELD IN LAS VEGAS NEVADA ON SEPTEMBER 20, 2007 AND IN THAT APPEAL I REQUESTED FULL REDRESS FOR LOSSES INCURRED.
